

# Members First Credit Union Facebook Contest Rules

## Member First Credit Union “Retirement Bucket List” Official Contest Rules

Members First Credit Union “Retirement Bucket List” Contest, (“the Contest”) starts on Monday, September 19<sup>th</sup>, 2016 at 12:00 a.m. Eastern Time (EST) and ends on Saturday, October 15<sup>th</sup>, 2016 at 11:59 p.m. EST (“Contest Period”). Winner will be announced not later than October 21<sup>st</sup>, 2016.

**RULES AND ELIGIBILITY:** The Contest is being conducted by Members First Credit Union (the “Sponsor”). Participation in the Contest is limited to individuals who are legal residents of the fifty (50) United States, and who are members in good standing of Members First Credit Union. Employees of Members First Credit Union and members of their immediate family (spouse and parent, children and siblings and their respective spouses, regardless of where they reside) and persons living in the same household, whether or not related, of such employees, are not eligible to enter the Contest or win any Contest prize. Anyone else connected in any way with the Contest or helping to set up the Contest shall not be permitted to enter the Contest or win any Contest prize. The Contest is subject to all applicable federal, state, provincial and local laws and is void where prohibited by law.

The Sponsor reserves the right to cancel or amend the Contest and these terms and conditions without notice in the event of a catastrophe, war, civil or military disturbance, act of God or any actual or anticipated breach of any applicable law or regulation or any other event outside of the Sponsor’s control. One entry per member will be accepted. If more than one entry is submitted by a contestant, the first entry will be selected, and all subsequent entries will be considered null and void. No responsibility can be accepted for entries not received for whatever reason.

By submitting the form via Members First Credit Union’s Facebook Contest page, Contestant is agreeing to comply with these Official Contest Rules and all such submittals that comply with these Official Contest Rules constitute Entries.

Entries generated by script, macro or other automated means and Entries by any means which subvert these Official Contest Rules are void. This Contest is in no way sponsored, endorsed or administered by, or associated with, Facebook or Wishpond. You understand and agree that you are providing your information to the Sponsor and not to Facebook or Wishpond.

**PRIZE WINNER SELECTION AND NOTIFICATION:** At the end of the Contest time period, a prize winner will be selected at random in accordance with Wishpond’s software and verified by Promoter and or its agents. The prize winner must meet the eligibility rules in order to receive the prize. Each selected winner will be notified by mail, phone, and/or e-mail. If a prize or prize notification is returned as undeliverable within seven (7) days after the winner announcement, Sponsor is unable to contact a selected winner or a selected winner has not complied with these Official Contest Rules, the prize will be forfeited and, at the Sponsor’s sole discretion, an alternate Contestant will be selected as the prize winner.
