

## **Members First Credit Union Contest Rules**

### **Member First Credit Union “Explore More Sweepstakes” Official Contest Rules**

Members First Credit Union “Explore More Sweepstakes”, (“the Contest”) starts on Monday, July 27, 2020 at 12:00 a.m. Eastern Time (EST) and ends on Friday, August 28, 2020 at 11:59 p.m. EST (“Contest Period”). Winners will be announced not later than September 11, 2020.

**RULES AND ELIGIBILITY:** The Contest is being conducted by Members First Credit Union (the “Sponsor”). Participation in the Contest is limited to individuals who are legal residents of the fifty (50) United States, and who are official members of Members First Credit Union with an MFCU in good standing. Employees of Members First Credit Union and members of their immediate family (spouse and parent, children and siblings and their respective spouses, regardless of where they reside) and persons living in the same household, whether or not related, of such employees, are not eligible to enter the Contest or win any Contest prize. Anyone else connected in any way with the Contest or helping to set up the Contest shall not be permitted to enter the Contest or win any Contest prize. The Contest is subject to all applicable federal, state, provincial and local laws and is void where prohibited by law.

The Sponsor reserves the right to cancel or amend the Contest and these terms and conditions without notice in the event of a catastrophe, war, civil or military disturbance, act of God or any actual or anticipated breach of any applicable law or regulation or any other event outside of the Sponsor’s control. Any changes to the Contest will be communicated to entrants as soon as possible by the Sponsor. No cash alternative to the prizes will be offered. The prizes are not transferable. Prizes are subject to availability and we reserve the right to substitute any prize with another of equivalent value without giving notice.

**HOW TO ENTER:** During the Contest Period, valid Contest entries (“Entries”) will be accepted when a contestant fills out the entry form on the Members First Credit Union Facebook page ([www.facebook.com/MembersFirstMI](http://www.facebook.com/MembersFirstMI)). One entry per member, per prize will be accepted. If more than one entry is submitted by a contestant per prize, the first entry will be selected, and all subsequent entries will be considered null and void. All fields must be completed for entry. No responsibility can be accepted for entries not received for whatever reason.

By submitting information, Contestant is agreeing to comply with these Official Contest Rules and all such submittals that comply with these Official Contest Rules constitute Entries.

Entries generated by script, macro or other automated means and Entries by any means which subvert these Official Contest Rules are void.

**PRIZE WINNER SELECTION AND NOTIFICATION:** At the end of the Contest time period, a prize winner will be selected as a result of a random drawing by Members First Credit Union. The prize winner must meet the eligibility rules in order to receive the prize. Each selected winner will be notified by mail, phone, and/or e-mail. If a prize or prize notification is returned as undeliverable within fourteen (14) days after the winner announcement, Sponsor is unable to contact a selected winner or a selected winner has not complied with these Official Contest Rules, the prize will be forfeited and, at the Sponsor’s sole discretion, an alternate Contestant will be selected as the prize winner. If a selected winner is considered a minor in his/her jurisdiction of residence, the prize may be awarded in the name of his/her parent or legal guardian who will be responsible for fulfilling all requirements imposed on winner set forth herein, or another Contestant may be selected for the prize, in the Sponsor’s sole and absolute discretion.
